Storage/Shelf Life	Store for up to 12 months from date of manufacture in original, unopened packaging under cool, dry, conditions within the temperature range of 5°C to 30°C and out of direct sunlight. Protect from frost.

Coverage	1 litre covers 2 to 4 square metres dependant on thickness and number of layers of paint
Penetration	Wait at least 30 minutes before checking, but typically up to 2 hours will give good penetration.  Do not allow to dry out.
Solvent for Cleaning Up	Water / White Spirit

#### **PREPARATION**

- 1. Protect Floor Coverings, textiles, plastic, rubberitems and any items sensitive to solvents.
- The product is flammable YOU MUST ensure there are no sources of ignition before using.
- 3. Agitate container to ensure uniform consistency.

#### APPLICATION

- 4. Ideally apply out of direct sunlight.
- 5. Apply a thick coat by brush. DO NOT BRUSHOUT. The thicker the paint, the more Nitromors you will require. If possible light scoring of thesurface will improve penetration.
- Check a small area with a scraper. If softened, then remove by scraping. A nylon toothbrush can be useful for getting into crevices. Areas of ingrained paint can be rubbed along the grain with steel wool dipped in Nitromors.

7. For multi-layered finishes, further Nitromors can be re-applied without removing the first coat.

#### **CLEANING**

8. Wash Down the surface with water and detergent. On fine wooden surfaces however use white spirits to wipe down.
