CEMENTONE WATERSEAL A WATER REPELLENT SOLUTION

Cementone Waterseal is a long lasting, deeply penetrating, water repellent solution for porous external walls and fascias. It deposits a waterproof resin in the capillaries of the substrate which expands on reaction with residual moisture and almost completely reduces rainwater penetration, whilst still allowing the substrate to breathe. This reduction of the movement of water through the structure improves insulation, reduces dirt retention, mould and algae growth. It also reduces the incidence of efflorescence. Cementone Waterseal is completely colourless although it may enhance the colour of treated surfaces in rare cases. Before using this product refer to the relevant Health & Safety Sheet.

Directions for use

IMPORTANT

Before using Cementone Waterseal refer to the relevant Health & Safety Data Sheet. Available at www.bostik.co.uk named as the code above.

Application

1. Surfaces must be clean, dry, porous and free of any contamination. Bitumen must be totally removed, as it will run.
2. Any structural defects, particularly mortar joints, must be made good and allowed to cure before application. Note: Cementone Waterseal will not seal and reduce penetration of water into open textured concrete blocks.
3. Apply one or two coats of Cementone Waterseal to the prepared surface using a large brush or low pressure spray equipment, care being taken to ensure no excessive over-spray or inhalation by the operative.
4. In exceptional circumstances further coats may be necessary.
5. Allow at least 2 hours between coats and do not apply to surfaces affected by rain or frost.
6. Take precautions to ensure Cementone Waterseal does not come into contact with glass window panes and decorative coatings, as it will be very difficult to remove once dry.

Cleaning

7. Clean tools immediately after use with white spirit.
8. Any over-spray MUST be removed with paint thinner or white spirit whilst wet.

Precautions in Use

Cementone Waterseal is not intended as a damp-proof membrane or in below ground waterproofing applications. It is not designed for use indoors or in enclosed areas, due to its solvent content.

This product should not be used for waterproofing ponds or pools. Also take care to prevent run-off getting into nearby pools or ponds.

It is not designed as a dustproofer for walls or floors.

The product works by lining the capillaries of the substrate. To be able to allow this the substrate **MUST** be both dry and porous. If it is applied to wet or non-porous surfaces either by design or accidentally it will dry to leave a white deposit, which is very difficult to remove.

If used indoors or in confined spaces the solvent will take much longer to evaporate. In some cases the odour of solvent may be present for many weeks.

If paint is to be applied the product must be completely dry and the surface weathered for at least six months. Always test a small area for paint suitability.
